# HUNTERDON COUNTY BUSINESS HALL OF FAME TO HONOR 2ND CLASS OF INDUCTEES

The Hunterdon County Chamber of Commerce Foundation has established the Hunterdon County Business Hall of Fame to honor current and past business leaders, businesses and organizations who have made important contributions to the community. The second class of Hall of Fame laureates will be honored during an induction ceremony at the Ryland Inn on May 7, 2019.

"The Hunterdon County Business Hall of Fame highlights exceptional leadership and innovation which is part of Hunterdon's rich history," said Foundation Board Member Rosemary Fellner, Chief Marketing Officer with Unity Bank. "By sharing the stories of the 2019 laureates, we hope to inspire more entrepreneurs to enrich our business community."

The Business Hall of Fame has a display at the Foundation, in the historic Reading-Large House in Flemington. A traveling kiosk for the Hall of Fame is being exhibited throughout the county at businesses, public locations and schools. The kiosk will share videos featuring honorees and their contributions to Hunterdon County.

The Hall of Fame induction ceremony will begin at 6 p.m. at the Ryland Inn, 115 Old Highway 28, Whitehouse Station. # 4 Mistakes to Avoid When Naming Beneficiaries Michelle Hein Ameriprise Private V

If you've ever spent time working through your estate plan with a professional, you know how important it is to select and update your beneficiaries. Failing to do so can result in costly mistakes – for you and your loved ones. Here are four common mistakes that can easily be avoided with a bit of proactive planning:

#### Mistake #1 - Not naming a beneficiary on all accounts.

Ensure you have beneficiary designations on all of your retirement, investment and banking accounts, as well as your insurance policies. If you don't name a beneficiary on one or more accounts, your estate becomes the beneficiary of that account and your loved ones will need to go through the probate process (a legal process most families want to avoid for financial and emotional reasons). If this happens, your relative can lose their ability to use "stretch" payouts based on their life expectancy because the tax-advantaged status for retirement assets is lost.

Mistake #2 – Forgetting to name a contingent beneficiary on all accounts. Many people list the same loved one – usually a partner or parent – as the primary beneficiary on most or all accounts. If this is how you've handled your assets, it is important for you to also name a contingent beneficiary. This is because if your primary beneficiary passes away first and no contingent beneficiaries are listed, it's comparable to having no beneficiary designation. If you both die at the same time, funds go into probate.

Naming contingent beneficiaries also gives the primary beneficiary the option to execute a qualified disclaimer so some assets can pass to next-in-line loved ones. For example, a primary beneficiary may not wish to claim the assets because of tax implications or because they don't need the assets and prefer instead to pass your gift onto another beneficiary.

Mistake #3 – Not using specific names. One mistake many people make is listing a generic term – such as children, parents or aunts – instead of specific names in their beneficiary selections. This can be problematic, especially if you are part of a blended family. Many states won't include or recognize stepchildren when the word "children" is listed. Another risk of vagueness is that a family member you've lost contact with may enter the picture and try to claim a piece of your remaining assets. With this in mind, make sure you use full names of each person when naming beneficiaries.

Mistake #4 – Failing to review your beneficiary selections regularly. Beneficiary designations override your will, so it's crucial to keep them up to date. You may need to update your choices every few years due to life changes, such as if beneficiaries have died or your relationship with them has changed. This is particularly applicable if you've gone through a divorce or remarried. If your ex-spouse inadvertently remains the designated beneficiary of an account, he or she may have the upper hand if the case winds up in court.

Estate planning isn't the most enjoyable part of planning for your financial future, but it is crucial to helping ensure that your assets are handled the way you desire after you no longer have control.





## Tax Tidbit: Change in Marital Status? What You Need to Know



Have you recently married, divorced, or lost a spouse? A change in marital status should prompt a review of financial matters, but at such a time it is easy to overlook the details. Here are a few reminders and suggestions:

Insurance coverage: When your marital status changes, review your insurance policies. Combining separately held health insurance policies with a spouse can result in savings and discounts. Most group health insurance policies allow spousal coverage. You may want to opt for coverage under your partner's policy if superior or less expensive coverage is offered. Married couples are often considered a better insurance risk, so together you may qualify for a lower rate. Also evaluate your need for disability or long-term care insurance.


Beneficiary designations: Review beneficiary designations on life insurance policies and retirement accounts.

Estate planning: Update choices that have become obsolete. Incomplete paperwork or inappropriate choices could mean your intended beneficiary may not end up with your assets. You should periodically review and update your existing will and other estate planning documents. This is especially important whenever your marital status changes. Before you get married, consider a prenuptial agreement if there are children from a prior marriage or if you own substantial assets.

Other documents: Review any other important documents. If you change or hyphenate your name, notify the Social Security Administration and Department of Motor Vehicles of your name change. Make copies of your estate papers and final divorce decree. Keep the originals in a safe place.

Tax planning: Your tax liability will likely change when you marry, divorce, or become a widow. Newlyweds may face higher taxes due to the so-called marriage penalty. In either case, you may need to change your income tax withholding or estimated tax payments.
